



## 50th Annual Training Event - Visionaries Keynote Proposals Terms and Conditions

### Eligibility:

NOVA values and embraces diversity and equal opportunity. People of Color, LGBTQIA+ persons, Deaf/Hard of Hearing, People with Disabilities, and survivors of violence are strongly encouraged to submit a video proposal.

- Individuals and groups of 3 max.
- All ages. Individuals 18 and under who are not legally emancipated youth, must have parent/guardian permission, acknowledgement of terms and media release found in NOVA's Visionaries Keynote Application.
- Students and/or Professionals with experience as an advocate, victim, or survivor of violence.
- Individuals who have already submitted a NOVA Annual Training Event workshop proposal are welcome to apply.
- Speaker(s) must agree to NOVA's acknowledgement of terms and media release found in NOVA's Visionaries Keynote Application.

**Deadline:** 8:00 pm Eastern Time on January 31, 2024

### Proposal Evaluation:

Video proposals will be reviewed by a team of subject-matter experts. Submitted content will be assessed based on the following:

- Video Proposal includes a clear explanation of an innovative idea related to any of the following areas:
  - Victim advocacy
  - Violence prevention
  - Engaging culturally specific and underserved communities
  - Technology and tools to better serve survivors
  - Crisis response
  - Mental health and self-care
  - Strengthening systems
- Knowledge and expertise of the presenter on the topic
- Clear explanation of how this innovative idea will better support survivors and communities in need
- Connection to NOVA's 50th Annual Training Event Theme "**50 & Forward: Advancing our Advocacy!**"
- Ability to draw interest, demonstrate impact, and appeal to NOVA's audience



### **Proposal Requirements:**

- Speakers must complete NOVA's Visionaries Keynote Application form.
- Video submissions should be emailed to [conference@trynova.org](mailto:conference@trynova.org) with the subject line "Visionaries Keynote Proposal" and must include the speaker(s) name.
- Video recording should be a max of 5 minutes.
- Videos can be submitted in any language.
- Only one video submission per speaker or group is allowed.
- Ensure maximum audio quality for voice recording by using a mic, headset, and recording in a quiet space.
- Increase visual clarity of your video by recording in a well lit space, with a solid background if possible.

### **Video submission and Media Release:**

Videos submitted may be broadcast on NOVA's website and at conference exhibits. By uploading your video you acknowledge and agree to the following:

- Give permission to NOVA to publish the video submission in our conference app, website, and release any copyright privileges to NOVA.
- Authorizing others working under NOVA's authority, to use photographs, video recording, likeness, voice, and name for any and all purposes, including marketing, commercial, or advertising purposes, and in any and all forms of media, without further consideration.
- Acknowledging that content submitted in this form does not belong to anyone other than myself, ideas and content shared are not property of any organization and therefore do not include any copyright or ownerships or proprietary info that would interfere with them being shared publicly.
