





2020 HIGHLIGHTS





NCVRW:

NOVA joined the Department of Justice Office for Victims of Crime (OVC) and victim assistance agencies across the country in observing National Crime Victims' Rights Week (NCVRW) in April! Over 1,500 advocates participated in a series of web events designed to advance their knowledge of: Marsy's Law for All; protecting and advancing victims' rights; and child exploitation & internet safety. In partnership with APPRISS Safety, NOVA hosted our 3rd Annual NCVRW Virtual 5K with over 245 advocates proudly participating in our walk and our #WhyWeAdvocate social media campaign.





NOVA'S VIRTUAL TRAINING EVENT:

NOVA went virtual to host our 46th Annual Training Event online during July! Over 1,300 attendees--including victim advocates, crisis responders and allied professionals from around the world--attended this two-week training event which featured dynamic plenaries, workshops, networking sessions, and self-care events designed to inspire, inform and re-energize our NOVA community.



NEW MILITARY/VETERANS TRAINING AND TECHNICAL ASSISTANCE PROGRAM:

NOVA, in partnership with the National Crime Victim Law Institute (NCVLI), launched a new TTA Program to support criminal justice professionals and advocates in responding to military-connected survivors of sexual assault, domestic violence, stalking and dating violence. Funded through the DOJ Office on Violence Against Women (OVW), this dynamic program is helping build military-civilian collaborative community response (CCR) programs in communities across the country.

COVID-19 RESPONSE



COVID-19 created new risks and barriers to service, justice and healing for victims of crime and crisis. It challenged all of us to step up and develop innovative ways to connect with and advocate for all victims, while also managing personal stress, anxiety, fear and frustration. To support our community, NOVA built a comprehensive, trauma-informed program with resources and opportunities for members to connect and learn from each other. As we navigate these uncertain times, NOVA will continue to provide a space for our community to exchange information, resources and receive support.

VIRTUAL GATHERINGS:

Since March, NOVA has hosted 13 virtual gatherings attended by over 3,000 members of our NOVA community. Such gatherings feature opportunities for members to learn, practice self-care and find connections within our virtual world.



NOVA TRAINING PROGRAMS

NATIONAL ADVOCATE LEADERSHIP CENTER (NALC):

The NALC is an online training and professional development center for those serving victims/survivors of crime. Each year, NOVA continues to push the boundaries in the professionalization of victim advocacy, seeking new solutions and best practices to meet the needs of those in the field. Through our innovative online trainings, nationally recognized subject matter experts, career development support and networking opportunities, we are committed to ensuring every victim advocate is equipped and qualified to serve those impacted by crime and crisis.



NOVA VICTIM ASSISTANCE ACADEMY (NVAA):

Since the first class in 2014, the NVAA has quickly grown into an established leader in the field of victim advocacy training. Pre-approved by the National Advocate Credentialing Program (NACP)[®], the NVAA is 40-hour live online training academy created for new and aspiring victim advocates.

NOVA CAMPUS ADVOCACY TRAINING (NCAT):

The NCAT is an advanced online acadamy that uses a blended-learning approach to build upon participants' knowledge and skills, instructing on best-practices in preventing and responding to the unique needs of those impacted by sexual assault, stalking and interpersonal violence in higher education.

NOVA CRISIS RESPONSE TEAM TRAINING™:

NOVA Crisis Response Team Training[™] has over thirty years of evidence-based and field-tested best practices as a crisis management utility. NOVA Crisis Response Teams are thoroughly trained to provide trauma mitigation, education and emotional first aid in the aftermath of a critical incident.







SEX TRAFFICKING ADVANCED VICTIM ASSISTANCE TRAINING (STAVAT):

This year, NOVA was excited to launch STAVAT in partnership with StrandSquared. Created to meet the unique demands of victim assistance professionals working with sex trafficking victims, this advanced training is a live, online-learning academy designed to provide concrete skills, best practices and lessons from the field.



An Eventful Year for NOVA's Crisis Response Program

2020 brought about a new set of challenges and opportunities for the NOVA Crisis Response Team Training™. COVID-19 made it impossible to conduct the standard face-to-face delivery of the NOVA CRT™ program. However; it provided us with the opportunity to develop and deliver our NOVA CRT™ Basic training virtually. In May of 2020 we delivered our first on-line Basic CRT course and we were fortunate to have as our inaugural class the Department of Homeland Security's Division of Investigations. Since this first training, we have been able to complete 4 other on-line trainings which brought together groups from The Cherokee Nation, Army, Navy, Air Force, Victim services of Ontario, Canada, and The South Dakota Network Against Family Violence & Sexual Assault.

In the last year, we trained individuals from 29 of the 50 states and completed six international trainings. Next year, we look forward to continuing our support to folks as they develop state/local teams and continue to deliver emotional support to communities impacted through crime and crisis.











2020 FINANCIAL SNAPSHOT

"As a NOVA Crisis Responder, I would like to share my love of the work we do. In 2002, I was trained along with twenty-two others from my community in the NOVA CRT method to respond to crisis and trauma. My intent at the time was to serve my own small community. We soon developed a County team, became part of the Ohio Crisis Response Team, and worked with NOVA. Our community expanded quickly.

Over these past seventeen years, my training has become an integral part of my life. I found the skills I had learned carried over seamlessly to my work as a school principal. Trauma is trauma whether it's a tornado, shooting, or losing a child from a medical issue. In each case our model took victims from their present state forward to look to the future.

For the past six years I have been a NOVA CRT trainer, enjoying each new class as they realize the tools they have gained through this training. I count myself very fortunate to be a part of the amazing work that NOVA does throughout the year and throughout the world."
