



## **D-SAACP Review Board Schedule**

### **Program Overview:**

The DoD Sexual Assault Advocate Certification Program (D-SAACP) recognizes the critical support Sexual Assault Prevention and Response (SAPR) Program Managers (PMs), Sexual Assault Response Coordinators (SARCs), and Sexual Assault Prevention and Response (SAPR) Victim Advocates (VAs) provide to victims of sexual assault from initial report through case conclusion, or until the point the victim no longer requires assistance. SAPR PMs, SARCs, and SAPR VAs certified through D-SAACP will join a growing field of certified civilian victim advocates who are trained and committed to upholding the highest standards of victim care and privacy.

### **Upcoming & Approaching Deadlines:**

NOVA and DoD SAPRO have collaborated to identify ways to incorporate more review boards for faster credentialing of the field. D-SAACP will conduct eight (8) review boards annually. Due to this periodicity, adhoc reviews will not be conducted in between boards. Please note that moving forward the deadlines are fluid to ensure that the reviews are happening approximately every six (6) weeks. The website will be updated to provide details for future boards.
