# How to Use the Guide



## Suggestions for Using the Contents of the Field-Generated NCVRW Resource Guide

This field-initiated National Crime Victims' Rights Week (NCVRW) Resource Kit, created for the 2026 NCVRW commemoration, features six documents to support your victim/survivor outreach and public awareness activities during the week of April 19 – 25, 2026:

## History of National Crime Victims' Rights Week

This brief historical overview of National Crime Victims' Rights Week, first proclaimed 45 years ago by President Ronald Reagan, demonstrates the nationwide community of crime victims/survivors and those who serve them in annually recognizing and honoring survivors.

## Sample Proclamation

The sample proclamation is designed to be personalized to the state/tribe/county/city from which the proclamation is being sought, prior to being submitted for consideration. Official websites may have "proclamation guidelines" to follow. Your request for an official 2026 NCVRW proclamation should be submitted **at least 60 days** in advance of NCVRW (February 20, 2026); and in addition to the draft proclamation, should include your name, organization, contact information, the purpose of the proclamation, a brief history of NCVRW (see above), and the requested date. Once the proclamation is issued, work with the state/tribe/county/city officials or entity to promote it (e.g., a photograph of the presentation of the proclamation, social media promotion, and/or posting on agency/ organization websites).

## Suggestions for Using the Contents of the Field-Generated NCVRW Resource Guide

### Sample Press Release

The sample press release is also designed to be personalized with information and quotations specific to the submitting agency/organization, and the community's plans for observing 2026 NCVRW. Generally, the mornings of Tuesdays through Thursdays are the best time to email press releases to the news media, at least one week in advance of when you would like coverage. The press release can be sent to journalists with whom you have had previous contact or to reporters who cover the "crime beat" in your community (often, their email addresses or social media handles are included with their byline). You can include a personalized "subject line" on your email that highlights the content of your press release, for example:

"Crime Survivors and Advocates Unite to Observe  
2026 National Crime Victims' Rights Week"

"There is Unity in the CommUNITY of Crime Survivor Support and Services"

# History of NCVRW



Forty-five years ago, on April 8, 1981, President Reagan proclaimed the first "Victims' Rights Week." His profound words from nearly four decades ago still resound today:

*"For too long, the victims of crime have been the forgotten persons of our criminal justice system. Rarely do we give victims the help they need or the attention they deserve. Yet the protection our citizens – to guard them from becoming victims – is the primary purpose of our penal laws. Thus, each new victim personally represents an instance in which our system has failed to prevent crime. Lack of concern of victims compounds that failure...We need a renewed emphasis on, and an enhanced sensitivity to, the rights of victims. These rights should be a central concern of those who participate in the criminal justice system, and it is time all of us paid great heed to the plight of victims."*

President Reagan's challenge for a "renewed emphasis" on victims' rights, issues and concerns was fully articulated in the work of his President's Task Force on Victims of Crime that he convened in 1982. Its Final Report, published in December 1982 with 68 recommendations for national action to improve the plight of victims, forged a path for victim assistance leaders and serves as an ongoing guide for justice professionals. Task Force Chairwoman Lois Haight explained, "The lessons of the victims run like a thread through and are the foundation of all the proposals that follow. Please take the time to learn, as we have, the depth and the human aspect of this grave social problem, then join in seeking and implementing the solutions."

The following year, the Office for Victims of Crime was created within the U.S. Department of Justice to implement recommendations from the President's Task Force on Victims of Crime. One of the most significant events in the history of the victim/survivor assistance profession was the passage of the Victims of Crime Act (VOCA) in 1984, which created the Crime Victims Fund, made up of federal criminal fines, penalties, and bond forfeitures, to support state victim compensation and local victim service programs. The Fund has provided support for National Crime Victims' Rights Week activities nationwide since 1990. The field of victim/survivor services continues its ongoing efforts to ensure the long-term sustainability of the Fund.

This time-honored annual NCVRW observance unites crime survivors, victim assistance and justice professionals, allied professionals, and communities across America each April to pay tribute to crime victims; listen to and learn from the immense power of their personal stories; and celebrate the many accomplishments that have strengthened laws and created policies, programs, and partnerships that identify and prioritize the needs of victims first.

The goal of NCVRW is to annually publicize and promote the needs, issues, and concerns of crime victims and survivors; the many services available to support them in the aftermath of crime; and the challenges that remain to promote individual and community safety across our Nation.

Your request for an official 2026 NCVRW proclamation should be submitted at least 60 days in advance of NCVRW (February 20, 2026); and in addition to the draft proclamation, should include your name, organization, contact information, the purpose of the proclamation, a brief history of NCVRW (see above), and the requested date. ## 2026 National Crime Victims' Rights Week Promotes CommUNITY in Victim/Survivor Services

(City/State)—The week of April 19 to 25, 2026 marks the 45th anniversary of National Crime Victims' Rights Week (NCVRW), first proclaimed by President Ronald Reagan in 1981. NCVRW is a time-honored tradition that recognizes the plight of victims and survivors, and elevates their voices so that when they speak, America can listen and learn.

The 2026 NCVRW theme, CommUNITY, emphasizes the “unity in the community” of countless people who support crime survivors – from victim service organizations to criminal justice and mental/behavioral health professionals, to multi-Faith institutions and leaders, and to family members and friends of survivors, among others. No crime survivor should have to endure the burden of victimization alone; there is a strong community of caring and concerned people nationwide who want to help them.

Today, there are over 12,000 community- and system-based organizations and agencies that assist survivors of crime; and over 32,000 laws that define and protect victims' rights. Crime survivors lead efforts to ensure support and services for fellow survivors, and to be treated with the dignity and respect they deserve.

However, many challenges threaten this broad commUNITY nationwide. Ongoing cutbacks to federal funding for victim/survivor services have resulted in significant reductions to greatly needed survivor services. Volunteers are needed to staff hotlines and strengthen efforts to support survivors. And sadly, too often crime survivors are still blamed and shamed for the crime that was committed against them.
